### Instructions for signing your codicil

1. Obtain two witnesses. They must not be beneficiaries under your Will or Codicil, their wives or husbands, or an executor. You must all three be present when the codicil is signed and witnessed.
2. Sign with your normal signature in ink.
3. The Witnesses must sign where shown and add clearly their full names, addresses and preferably their occupations.
4. Do not attach paper clips or pins to your Codicil as this may cause difficulties in proving your Will with the Probate Registry.
